

PerkinElmer LC 300 HPLC & UHPLC 2021 EU Research Contest

Official Contest Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT IMPROVE YOUR CHANCE OF WINNING. BEFORE YOU ENTER, READ, AND UNDERSTAND THESE OFFICIAL RULES. BY SUBMITTING AN ENTRY, YOU FULLY AND UNCONDITIONALLY AGREE TO AND ACCEPT (1) THESE OFFICIAL RULES; (2) PERKINELMER'S PRIVACY POLICY AVAILABLE AT THE WEBSITE DESIGNATED IN SECTION 11 BELOW; AND (3) THAT YOUR ENTRY AND THE PERSONAL INFORMATION COLLECTED FROM YOU IN CONNECTION WITH THIS CONTEST WILL BE USED BY PERKINELMER (AS DEFINED BELOW).

- 1) **Eligibility.** This is a trade promotion contest. Eligibility is limited to natural persons not acting on behalf of a business entity, who are legal residents of countries listed in Annex 1, and who are at least eighteen (18) years of age as of the date of entry (Entrants). Entrants need to have a Research Project that demonstrates either practical or innovative applications of the LC 300 UHPLC or LC 300 HPLC Systems in a business entity or in a government accredited institution (Research Project). Employees of PerkinElmer, Inc., its affiliates, subsidiaries, agents, distributors, advertising, promotion and production agencies, members of their immediate families, and their household members, are **not** eligible to participate or win. Any person who was awarded a prize or received other promotional consideration from the Sponsor (as hereinafter defined) within six (6) months prior to the entry deadline of this promotion is also **not** eligible to win or participate. **THIS PROMOTION IS VOID WHERE PROHIBITED OR RESTRICTED BY LAW AND IS SUBJECT TO ALL APPLICABLE STATE AND LOCAL LAWS AND REGULATIONS.**

- 3) **Contest Period.** This Contest will begin at 12:00 a.m. Greenwich Mean Time on April 1, 2021 and end at 11:59 pm Greenwich Mean Time on October 1st, 2021 (the "**Contest Period**"). All valid entries registered or received by PerkinElmer by 11:59 p.m. Greenwich Mean Time on October 1st, 2021 will be eligible to win the Prize (as hereinafter defined). PerkinElmer assumes no responsibility for late, lost, damaged, misidentified, or misdirected entries. Entries not received during the Contest Period will not be accepted.
- 4) **How to Enter.** No purchase is necessary to enter or win, and purchase will not affect your odds of winning. The odds of winning this promotion depend on the number of eligible entries received only. These rules form a binding legal agreement between you and PerkinElmer with respect to the Contest. Please read these rules prior to entry to ensure you understand and agree.

It is sole responsibility of the Entrant to comply with their employer's policies which they may be subject to with respect to the Contest. Entries that are incomplete are considered void and will not be accepted.

Limit one (1) entry per person. Use of any means to enter multiple entries into the Contest is prohibited and any multiple entries will be disqualified. Incomplete and/or incoherent entries are void and mechanically reproduced, software-generated or other automated multiple entries are not permitted. PerkinElmer reserves the right, in its sole discretion to disqualify any entries by persons that appear to be tampering with or abusing any aspect of this promotion. Entrants are permitted to enter other research contests published by PerkinElmer but may only win one Prize. Multiple Prizes will not be awarded.

5) **Research Project Submission Requirements.** In addition to the requirements listed under Section 4 above submission must meet the following criteria (collectively, "**Submission Requirements**"):

- It must not be derogatory, offensive, threatening, defamatory, disparaging, libelous or contain any content that is inappropriate, indecent, sexual, profane, tortuous, slanderous, discriminatory in any way, or that promotes hatred or harm against any group or person, or otherwise does not comply with the theme and spirit of the Contest.

- The Project and/or the submission is not the subject of any actual or threatened litigation or claim.
- The Entrant does not include any disparaging remarks relating to the Sponsor or a third party.
- Submission is two-dimensional and scannable (e.g., no videos or GIFs).

During the Contest Period, the Sponsor, its agents and/or the Sponsor's judges will be evaluating the submissions to ensure that they meet the Submission Requirements. The Sponsor reserves the right, in its sole discretion, to disqualify any Entrant who submits a Research Project that does not meet the Submission Requirements. Incomplete entries or entries not complying with these rules are subject to disqualification.

6) **Conditions of Entry.** Entrants agree to be bound by these rules and all decisions of PerkinElmer and PerkinElmer's Contest judges, whose decisions will be final and binding on all matters related to the Contest. By submitting an entry, participants grant to PerkinElmer, its agents and others working on their behalf the right to use the winner's name for advertising and marketing purposes, without additional compensation, unless otherwise prohibited by law. Further, with your entry, you may provide consent to receive promotional or marketing material and information from PerkinElmer or its affiliates. You may opt in in order to receive such information, which will not affect your chances of winning. All entries become the property of PerkinElmer and will not be acknowledged or returned. 7) **Judging.** Each Submission will be evaluated and scored based on the following "**Criteria**": (i) showing the need for the equipment to complete research project described (40%); (ii) clarity of application and application described (30%); (iii) uniqueness of application described (30%); and (iv) adherence to the Research Project

Requirements. Using the aforementioned Criteria, PerkinElmer judges will evaluate the entries based on the Criteria and determine in their sole judgment and authority whether there are any winners from those that satisfy the Criteria. There will be no more than one (1) winner for the Grand Prize and one (1) winner for the Runner Up Prize. The final result will be announced on or about November 1st, 2021. Each Entrant determined as a potential winner must comply with the terms and conditions set forth in these rules, and winning is contingent upon fulfilling all such requirements. If an Entrant does not provide the data required at entry, that Entrant's entry will be ineligible. The potential winner will be notified by mail, e-mail and/or phone and, where permitted by law, will be required to sign and return requires waivers, an affidavit of eligibility, a publicity and liability releases and disclaimers, within fourteen (14) days of attempted notification. - 8) **Prizes.** The two (2) first-place winners will each receive the Grand Prize described below and the second-place winner will receive the Runner Up Prize described below. All Entrants will receive the Participation Prize described below. The Grand Prize, the Runner Up Prize, and the Participation Prize are collectively referred to in these terms as "Prize".
- (a) **Grand Prize.** The "**Grand Prize**" winner will receive the use of one (1) LC 300 HPLC or LC 300 UHPLC system for a period of one (1) YEAR, with an approximate retail value EUR 21,500. This will include the installation of the System by PerkinElmer and up to 3 days of Training and Application consultation. User is responsible for any consumables required for use of the system and for supplying a suitable working area in accordance with the system product documentation. This prize is subject to the winner entering into an instrument loan agreement on PerkinElmer's form in a format acceptable and agreeable to PerkinElmer. A copy of the loan agreement will be provided to the Grand Prize winner after notification of award.
 - (b) **Runner-Up Prize.** The "**Runner Up Prize**" winner will receive a voucher entitling them a fifty percent (50%) off the country list price for PerkinElmer LC 300 HPLC or LC 300 UHPLC. The voucher must be used within twelve (12) months of award.
 - (c) **Participation Prize.** The "**Participant Prize**" will be afforded to all Entrants that are not awarded the Grand Prize or Runner Up Prize and will allow for such Entrants to receive a voucher entitling them a thirty-five percent (35%) discount off the country list price for any PerkinElmer HPLC & UHPLC system. The voucher must be used within twelve (12) months of award.

Two (2) Grand Prize Winners and a single Runner Up Prize winner will be selected from the eligible entrants (Section 1, 3, 4 & 5) received from across the eligible countries listed in Annex 1.

Each prize is nontransferable and must be accepted as awarded. Winner shall maintain the System in accordance with the product documentation and shall permit PerkinElmer to inspect the System from time to time with prior reasonable notice. Further, the System shall not be moved from the original place of install without PerkinElmer’s prior written notice and consent. The System shall always remain and be deemed personal property even if it may become attached or fixed to realty. Title to the System shall remain solely with PerkinElmer, and winner is only granted a limited right to use the System for one (1) year from the date of delivery. No right, title, or interest in or to the System shall ever pass to winner, unless winner decides to purchase the System under a separate written agreement. Winner shall (i) not convey, sublease, sell, transfer, assign, mortgage, grant security interests to, or otherwise encumber the System, nor shall it permit any lien or encumbrance upon or against any interest in the System (“Encumbrances”), (ii) give immediate written notice to PerkinElmer of any attempt to create such lien or other Encumbrance, and (c) at its sole expense, defend, indemnify and hold PerkinElmer harmless from and against any claims, damages, costs, expenses, losses or the like arising from any such Encumbrance on PerkinElmer’s title and interest in the System. Winner hereby grants PerkinElmer the right, with reasonable notice by PerkinElmer to winner, to enter winner’s premises where the System is installed premises for the purposes of performing scheduled maintenance of and repairs to the System as provided herein and to audit it. Upon expiration of the one (1) year period, winner shall return (or allow access for PerkinElmer to retrieve) the System to PerkinElmer. Winner shall enter into a loan agreement with PerkinElmer that will cover any additional obligations as it relates to the System.
